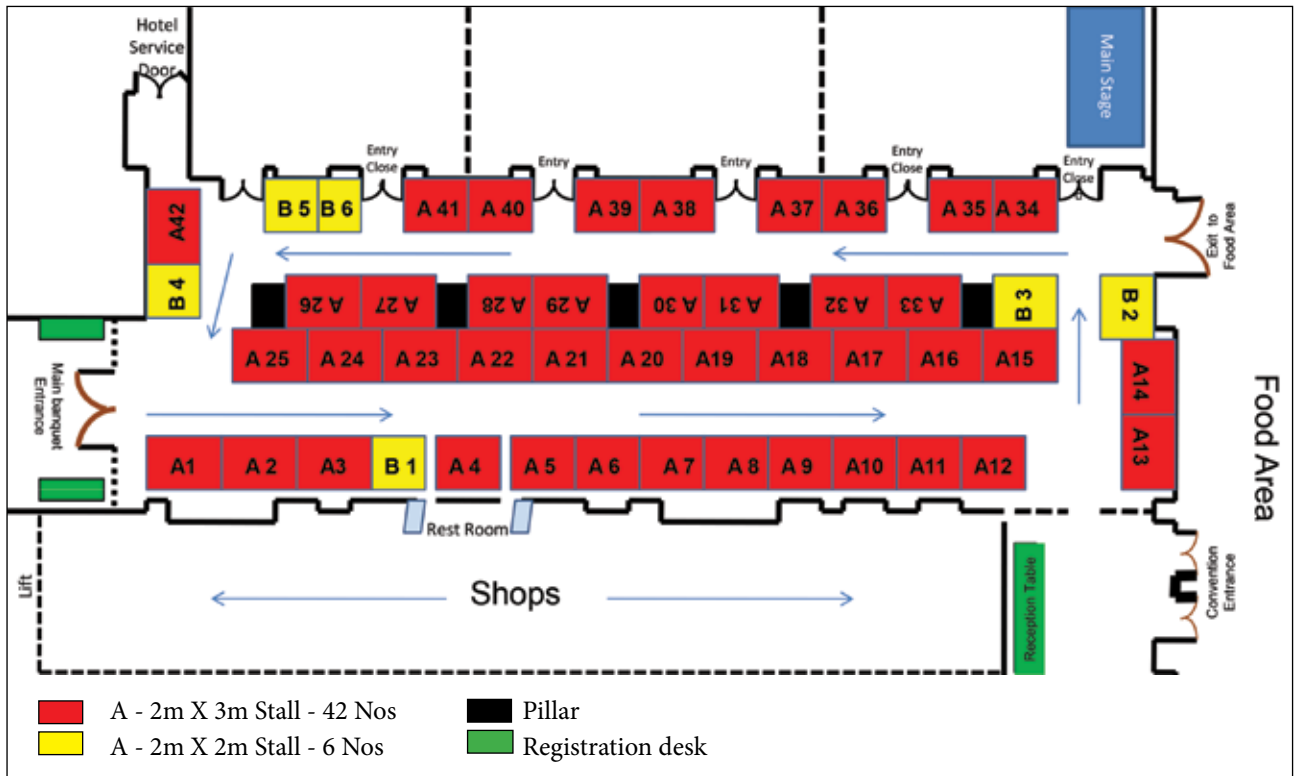

Participation:

Application for participation is to be made in the prescribed form. Approval of participation and exhibits will be at the sole discretion of WICMA.

Allocation of Space:

Space allocation will be done on first-cum-first-served basis-only on receipt of application form duly completed along with 100% payment. Space will be allotted to participants at WICMA's discretion only. Decision by WICMA will be final and binding.

Cancellation of Space:

In the event, that the participant:

- a) cancels its space booking; or
- b) fails to meet any of the payment obligations (whether as to the amounts due or dates of payment); or
- c) fails to occupy space allotted to them by the opening time on the 1st day of the Exhibition. **WICMA reserves the right to apply cancellation charges on the total charges for the space booked**, Notwithstanding that WICMA may re-sell or reallocate the cancelled space after cancellation by the participant, WICMA shall be under no obligation to reimburse all or any part of the cancellation charges.

Operation of Stand:
